## 1.1 PROJECT INFORMATION

- A. Notice to Bidders: Qualified bidders are invited to submit bids for Project as described in this Document according to the Instructions to Bidders.

## 1.2 BID SUBMITTAL AND OPENING

- A. Sealed bids will be received until the bid time and date at the location indicated below.

- B. Bids received after the time and date specified above will not be considered.
- C. Sealed Proposals shall be clearly marked on the outside of the envelope.
- D. Bids will be thereafter publically opened and read aloud.
- E. Each sealed bid shall be accompanied by either a cashier's check or satisfactory bid bond, in a sum, which is not less than five percent (5%) of the aggregate amount of the bid, payable to the City of Grayson Tourism and Convention Commission.
- F. The successful Bidder will be required to execute and to provide construction contract security in an amount no less than one hundred percent (100%) of the bid. The project will be required to be completed by two hundred (200) calendar days from the issuance of the Notice to Proceed to successful bidder.

## 1.3 BID SECURITY

- A. No bids may be withdrawn for a period of 60 days after opening of bids. The Owner reserves the right to reject any and all bids and to waive informalities and irregularities. All rights are reserved by the Owner to consider alternates as they determine to be in their best interest.
- B. Contract will be awarded on the basis of the Owner's determination of the best Bid, and the terms deemed most acceptable to the Owner, as determined solely by the Owner.
